An update on construction in your neighborhood

Dear neighbor,

We are writing to update you regarding ongoing construction on Clark Avenue and Hicksville Road in Massapequa, NY. As part of the final stages of our construction project, crews need to connect the installed upgraded infrastructure to the existing infrastructure. So, **beginning on/or around Friday**, **July 19**th **and Monday**, **July 22**nd, traffic will be impacted at the intersection of Hicksville Road and Clark Avenue and expect increased personnel on-site to perform these key activities. For your safety, please do not enter work zones and be mindful of construction during and after work hours.

What to expect:

- Construction hours are Monday through Friday, 7AM to 4PM*.
- Traffic impacts at the intersection of Hicksville Road and Clark Avenue during construction hours. Traffic flaggers will be on-site to direct vehicles through the work zone.
- Intermittent road closures on Clark Avenue between Hicksville Road & Forest Avenue. Please use alternate streets while navigating the neighborhood. Traffic flaggers will be on-site to assist local traffic to and from their homes.
- Excavations will be secured and plated after construction hours.

Once these activities are completed, crews will begin to backfill and restore impacted areas to the Town of Oyster Bay specifications. **This project remains on track to be completed this Summer 2024.**
