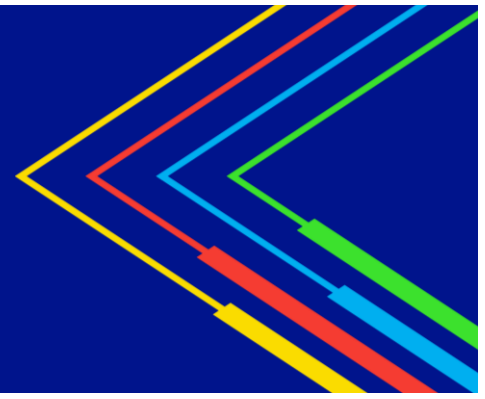

NL-38 Regulator Station Refurbishment Project

Dear Neighbor,

We are writing to update you regarding ongoing work in your neighborhood. We are currently upgrading our existing regulator station, located on the property of Roslyn Village Hall, 1200 Old Northern Boulevard.

A map of our work area is included for reference below. The National Grid project scope is limited only to the area highlighted in orange. **National Grid and Safeway are not associated with construction activities east of the site near the intersection of Old Northern Boulevard and East Broadway.** Please contact the Village of Roslyn Main Village Hall at 516-621-1961 for questions regarding work in that location.

A detailed project fact sheet is attached to this letter. Once completed, the new station will improve reliability of service throughout your neighborhood and increase safety. Impacted areas, including Roslyn Village Hall parking lot and Old Northern Boulevard, will be fully restored to Village and Nassau County specifications. The project is expected to be completed in fall 2023.

We thank you for your continued patience as we work to complete this important infrastructure work.

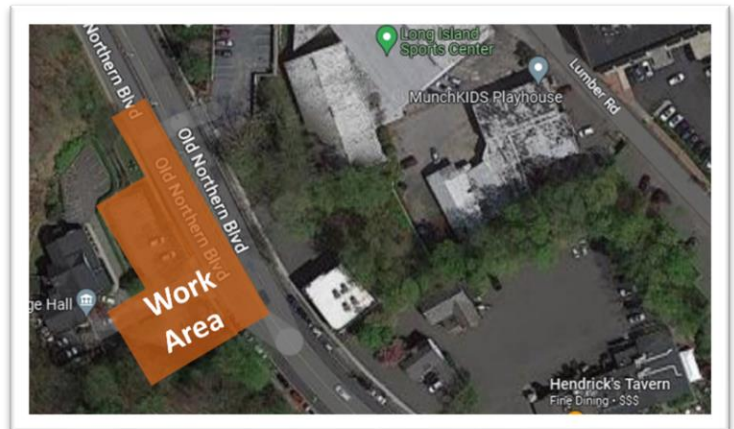

We are currently working in your neighborhood. Energy plays a critical role in our day-to-day lives and helps ensure the well-being of our community. That's why we're investing in infrastructure upgrades in your area.

Project details:

This project is upgrading our existing regulator station on Old Northern Boulevard in Roslyn, NY to improve system integrity and reliability of service for our Roslyn customers. There will be no interruption of service for our customers. The station is located in the parking lot of Roslyn Village Hall.

What to expect during construction:

- **Excavations:** Digging up of public roadways and or/sidewalks on Old Northern Boulevard, in front of Roslyn Village Hall. Open pits are plated and secured during non-working hours.
- **Parking:** This project has impacted parking at Roslyn Village Hall. Signage is posted to direct visitors where to park.
- **Traffic pattern changes:** Vehicle and pedestrian traffic is open during construction, however, there are lane closures on Old Northern Boulevard in front of Roslyn Village Hall. Please be mindful of construction traffic, flaggers, signs and cones. Northern Boulevard will be secured and plated during non-work hours.
- **Restoration** of any disturbed roadway/sidewalk areas.
- **Direct contact with our Outreach Team.** If you have questions or concerns, please call or email our team.
