Still testing. Include NETMETER instead of Y/YES or N/No

### CC027 - 814E REF\*7G new REF02 Code CAB

Eversouce only–implemented.

#### CC028 - 814C REF\*7G new REF02 Code C14

Eversource only - implemented. Only accepting 1 change per account per day

CC029 - 810 REF\*QY gray box

Restore info from previous IG versions.

Kim Wall raised issue that this field is not truly being used for Life Support indicator but rather Primary Metering Indicator.

Legacy NU does use as Primary Metering Indicator

NGRID uses for Life Support

Eversource East - to research

Liberty – to research
