 - a) 029 – REFQY revision – Update REF02 with possible values and Utility Usage.
 - b) 031 – Eversource adding REF*BF to 867H and 814H – ETA end of year

4. NGRID Update on 814C issues:
 - a) Repeating REF*TD for same REF02: IT is working on suppression the second REFTD. REFRB change can be echoed on Response but not on NGrid initiated Request.
 - b) Invalid REF02: NM1MR
5. NGRID update on manual enrolls and drops
 - When customer calls call center and requests drop, not triggering EDI. Lists are emailed weekly to suppliers.
 - Billing issue is treating rate change as new enrollment blocking actual enrollment. Manually correcting internally and emailing weekly reports to suppliers.
 - NGRID not to correct via EDI in current system. New Billing System in works and will be built in. No ETA yet.
 - Charles Paris (Town Sq) Manual enrolls only have start date. Missing other key info. Form sub-group of suppliers to discuss and finalize list of fields.
 - Email sent after call with list of updated fields to be included on weekly reports.
6. ICAP Tag Updates - Each utility to report how the suppliers are to obtain the June 1 updates. Include all utilities in MA, NH, RI.

7. K2 (kVAR) vs. K4 (kVA)

- Any utilities who are still using "K2" instead of "K4" need to report progress on correcting the value.
 - a) Eversource East is correcting in July
 - b) NGRID uses K2, should change to K4 KVA
- Eversource (CLP, PSNH, WMECO) is resolved. CC 030
- Narragansett in Rhode Island still sending K2, did not find any other examples.
- Can utilities, suppliers check for other utilities that may still be sending K2?

8. Net Meter Indicator

- Unitil does not send the 814 Change transaction for the REF*KY*NETMETER, nor do they appear to include it on the 810. How can we obtain updates?
 - a) It is sent on the 867H and will be added to Synch List
- MECO sends standard implementation (814E, C, 867HU). Would Nantucket be the same if net meters are implemented?
 - a) NGRID should be sending on enroll but apparently not there. Narr/Nant operate the same. Request from 2014 still pending internally. Implemented on 814C and 867H. Missing on just Enroll.
- No examples for Narragansett (RI)... any idea whether this would be implemented there if net meters are implemented?
- NHEC - do we invite them to our meetings? Any idea if they've implemented Net Meter indicator in any way?

- Daryush/Cathy - sync list has enroll date but has issue picking up clean energy. Should be resolved weekend of 6/15. Tax Exemption percentage on EDI being corrected to be accurate.
