 - Tax Exempt Changes multi POD
 - If supplier submits change on 1 POD then all will be changed and Eversource will issue 814C request to other suppliers.. Target implementation 12/20
 - How is exemption removed? AMTDP 814C with AMT*T*1
 - What if supplier has proof of exemption from Customer for 1 POD but receive change.
 - Currently no accounts with POD IDs with diff suppliers.
 - 820 deployed 11/29 code change to add 3 char pref to trace numbers. Visible on 12/2 trans
 - Hansen Does that mean the dollar amount on 820 trans matches bank payment? Should be but not happening.
 - Hampshire Power the 3 char prefix is to help tie to physical payment. Payments are done by class. Payments are done monthly.
 - Net Metered accounts known defects
 - No update available from IT yet
 - O Continue to submit issues to supplier services email.
 - Rate issue for billing.
 - May be related to legacy Nstar process.
 - Advise to review enroll/change price to ensure 7 digits and contact supplier services
