NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 24-64 May 23, 2024

Petition of Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid, for review and approval by the Department of Public Utilities of Proposed Electric Vehicle Program Factors.

On May 15, 2024, Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid (together, "National Grid" or "Company"), filed its annual Electric Vehicle ("EV") program cost recovery filing with the Department of Public Utilities ("Department") seeking approval to recover costs associated with its Phase I, Phase II, and Phase III EV programs ("EV Programs") through proposed EV program factors for effect July 1, 2024. This filing was made pursuant to Massachusetts Electric Company and Nantucket Electric Company, D.P.U. 17-13 (2018), Massachusetts Electric Company and Nantucket Electric Company, D.P.U. 18-150 (2019), Electric Vehicles, D.P.U. 21-90/D.P.U. 21-91/D.P.U. 21-92 (2022), and the Company's EV program tariff, M.D.P.U. No. 1504. The Department has docketed this petition as D.P.U. 24-64.

National Grid seeks recovery of costs associated with its EV Programs, consisting of: (1) \$995,779 in incremental labor, contract labor, and burdens costs; (2) \$4,041,387 in incremental operations and maintenance costs; (3) \$376,661 in off-peak charging rebate costs; (4) \$92,508 in infrastructure costs; (5) \$4,384 in return, tax, and depreciation costs; (6) \$114,876 in costs for Clean Energy 2.0, the Company's online application portal for its Phase III EV program; and (7) \$10,027 in program management costs. Additionally, the Company proposes a reconciliation adjustment of \$58,887 to recover a past period under-recovery and to collect \$140,439 in estimated carrying charges over the recovery period. In sum, National Grid proposes to collect \$5,834,949 through the following EV program factors for effect July 1, 2024:

If the Company's request is approved as proposed, a typical National Grid residential basic service customer using 600 kWh of electricity per month will experience a monthly bill increase of \$0.12, or 0.1 percent, and a typical National Grid residential low-income basic service customer using 600 kWh of electricity per month will experience a monthly bill increase of \$0.08, or 0.1 percent, as compared to current rates. The Company states that bill impacts for commercial and industrial customers will vary based on rate class and usage. Customers may contact the Company for specific bill impact information.

Additionally, as part of its initial filing and consistent with the Department's directives in D.P.U. 21-90/D.P.U. 21-91/D.P.U. 21-92, at 185, to develop a joint state-wide program evaluation plan for Department approval and stakeholder input, National Grid submitted a joint state-wide program evaluation plan for its EV program. The Company also filed its 2023 annual report on its EV Programs, including its metrics on implementation, performance, and equity.

Any person who desires to participate otherwise in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Wednesday**, **June 12, 2024.** A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to

petitions to intervene must be filed by the close of business (5:00 p.m.) on the <u>second</u> business day after the petition to intervene was filed.

The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 24-64); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document.
