NOTICE OF PUBLIC HEARING AND REQUEST FOR COMMENTS

D.P.U. 24-99

July 19, 2024

Petition of Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid for Approval of a Mid-Term Modification to its 2022-2024 Three-Year Energy Efficiency Plan.

On June 24, 2024, Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid ("Company"), filed a petition with the Department of Public Utilities ("Department") seeking approval of a mid-term modification to its 2022-2024 Three-Year Energy Efficiency Plan ("Three-Year Plan"), which was filed in D.P.U. 21-123 and approved by the Department in <u>2022-2024 Three-Year Energy Efficiency Plans</u>, D.P.U. 21-120 through D.P.U. 21-129 (2022). The Department docketed this matter as D.P.U. 24-99.

The Company proposes to modify its Three-Year Plan to increase its Department-approved energy efficiency budget in the Residential and Income-Eligible sectors. Specifically, the Company seeks:

- to increase the budget for its Residential Hard-to-Measure program by approximately \$8.4 million (or 17 percent). The Company maintains that the proposed increase is driven by greater than larger than anticipated loan amounts and higher than anticipated interest rates in the Mass Save HEAT Loan core initiative. The Company states that it will use the increased budget to continue to provide HEAT Loans to interested customers;
- to increase the budget for its Income-Eligible Existing Buildings program by approximately \$81.1 million (or 55 percent). The Company states that the proposed increase is driven by the Income-Eligible Coordinated Deliveries core initiative, which provides energy efficiency services and products to income-eligible residential customers. The Company maintains that it has experienced unprecedented demand for income-eligible projects, at a higher cost per project than planned. The Company states that it will use the increased budget to continue to offer incentives to income-eligible customers in these programs; and

to increase the budget for its Income-Eligible Hard-to-Measure program by \$300,000 (or six percent). The Company states that the main drivers of this increase are:
(1) increased marketing costs as the Company sought to drive participation in its income-eligible programs; and (2) a higher than planned assessment from the Department of Energy Resources ("DOER") to the Company related to DOER's oversight and coordination of the energy efficiency programs.

On June 24, 2024, the Department approved a prior mid-term modification that: (1) increased the Company's budget for the Residential sector; and (2) decreased the Company's budget for the Commercial and Industrial ("C&I") sector. <u>Massachusetts Electric</u> <u>Company and Nantucket Electric Company</u>, D.P.U. 23-154, Stamp Approval (June 24, 2024).

If the Department approves the budget increases as proposed for this latest mid-term modification, the Company states that customers will experience the following additional bill impacts:

- a residential customer (R-1) using 500 kilowatt-hours ("kWh") of electricity per month will experience a monthly bill increase of \$3.14 (or 1.7 percent);
- a low-income residential assistance customer (R-2) using 500 kWh of electricity per month will experience a monthly bill increase of \$1.84 (or 1.6 percent); and
- C&I customers will experience bill increases ranging from 0.5 percent to 1.6 percent. These customers should contact the Company for specific bill impact information.

The Department will conduct a public hearing to receive comments on the Company's petition on **Tuesday, August 6, 2024, beginning at 2:00 p.m**. The hearing will be virtual and use Zoom videoconferencing. Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **Tuesday, August 6, 2024**. Please note that in the interest of transparency any comments will be posted to our website as received and without redacting personal information, such as addresses, telephone numbers, or email addresses. Therefore, consider the extent of information you wish to share when submitting comments. The Department strongly encourages public comments to be submitted by email using the methods described below. If, however, a member of the public is unable to send

written comments by email, a paper copy may be sent to Mark D. Marini, Secretary, Department of Public Utilities, One South Station, Boston, Massachusetts, 02110.

Any person who desires to participate otherwise in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Friday**, **August 2, 2024**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed.

To the extent a person or entity wishes to submit comments or a petition to intervene in accordance with this Notice, electronic submission is sufficient. All documents must be submitted to the Department in **.pdf format** by e-mail attachment to <u>dpu.efiling@mass.gov</u> and <u>krista.hawley@mass.gov</u>. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 24-99); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document.
